COMPLETION OF QUALIFYING TRANSACTION

Vancouver, British Columbia, April 17, 2020 — Caprice Business Development Canada Inc., which has now changed its name to "Leaf Mobile Inc." (TSXV: LEAF, formerly "CAPB.P") ("**Leaf Mobile**") is pleased to announce the completion of its qualifying transaction, previously announced on August 9, 2019 and on January 31, 2020.

Under its qualifying transaction, Leaf Mobile completed a reverse takeover transaction with 1182533 B.C. Ltd. Immediately beforehand, 1182533 B.C. Ltd. completed an acquisition of LDRLY (Technologies) Inc., which develops and publishes casual or idle mobile games, including titles such as *Bud Farm Idle Tycoon*. As a result, Leaf Mobile is now the parent company of LDRLY (Technologies) Inc.

Immediately prior to completion, 1182533 B.C. Ltd. completed a private placement of 21,856,250 shares at \$0.16 per share, for aggregate proceeds of \$3.5 million. Haywood Securities Inc. received a cash finder's fee of \$66,000, and 412,500 brokers warrants. The shares issued by 1182533 B.C. Ltd. were exchanged for Leaf Mobile common shares on a 1:1 basis under the qualifying transaction, and aforementioned broker warrants will be exercisable into Leaf Mobile shares.

Pursuant to the qualifying transaction, Leaf Mobile issued a total of 207,806,250 common shares, of which 122,387,500 shares will be subject to escrow on a Tier 2 surplus security release timeline, and 43,000,000 shares will be subject to escrow on a Tier 2 value security release timeline. 1,000,000 Leaf Mobile shares were also issued with respect to a finder's fee payable to an arm's length party.

As a result of the qualifying transaction, Eastside Games Inc. and Durban Holdings Ltd. are each "control persons" of Leaf Mobile, by reason of each holding over 20% of the outstanding Leaf Mobile common shares.

Leaf Mobile also announces that Darcy Taylor has been appointed as CEO and a director. Additionally, Brian Wideen has been appointed as VP Finance. Mark Tommasi has resigned as a director, and he is thanked for his service.

Trading of Leaf Mobile's common shares will commence on the TSX Venture Exchange under the symbol "LEAF", effective at the opening on Tuesday, April 21, 2020.
