



East Side Games Group Announces Results of 2023 Annual General & Special Meeting

Vancouver, BC, May 25, 2023 – East Side Games Group (TSX: EAGR) (OTC: EAGRF) ("**ESGG**" or the "**Company**"), is pleased to announce the voting results from its annual and special general meeting (the "**Meeting**") held on May 9, 2023. The total number of shares represented by shareholders present in person and by proxy at the Meeting was 38,310,608 common shares representing 46.99 % of the Company's issued and outstanding common shares.

All of the matters put forward before shareholders for consideration and approval, as set out in the Company's management proxy information circular dated March 31, 2023, were approved by the requisite majority of votes cast at the Meeting.
